

## ACTIVITY RELEASE OF LIABILITY

In exchange for participation in the activity of any A Colorful Universe events and activities in or outside of the store (Day Camp, Kid's Night, Drop and Shop, Morning/Afternoon Drop-Off) organized by A Colorful Universe, Inc. ("A Colorful Universe"), of 1523 San Elijo Rd. South Suite 106, San Marcos, California, 92078 and/or use of the property, facilities and services of A Colorful Universe, I agree for myself and (if applicable ) for the members of my family, to the following:

- **1**. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by A Colorful Universe, or the employees, representatives or agents of A Colorful Universe.
- 2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge A Colorful Universe for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of A Colorful Universe, whether caused by the fault of myself, my family, A Colorful Universe or other third parties.

# AUTHORIZATION AND CONSENT OF PARENT(S) OR LEGAL GUARDIAN(S)

I do hereby solemnly swear that I have legal custody of the aforementioned minor child/children. I grant my authorization and consent for A Colorful Universe, Inc. It is understood that this authorization is given in advance of any such medical treatment, but is given to provide authority and power on the part of the Supervising Adult in the exercise of his or her best judgment upon the advice of any such medical or emergency personnel.

Morning Drop Off and Late Pick Up Acknowledgement

**Morning Drop Off:** 



Our normal store opening hours are at 10am everyday. We gladly offer Morning Drop Off at 9am for a \$5/per child charge.

### Late Pick Up:

Camp: Our normal camp hours run from 10-2pm. Any pick-up's made after 2:15pm will result in a \$5/per child/per hour fee, rounding to the next hour.

Kid's Night Out: Our normal Kid's Night Out runs from 6-9pm (unless specified) Any pick-ups made after 9:15pm will result in a \$10/per child/per hour fee, rounding to the next hour.

## **Deposit and Cancellation Policy**

#### **DEPOSIT**

We require a credit card held on file to hold your child's place in Camp and/or Kid's Night Out. We **do not** run/process your credit card unless there is a no call/no show or less than 20 hour cancellation for Kid's Night Out. **Camp balance must be paid in full** 20 hours before reservation to secure spot. We accept all major credit cards.

## No Call / No Show

**Kid's Night Out:** Full amount per child, additional sibling cost and any other children under the reservation will be charged.

**Camp:** If reservation is made within 20 hour window, a \$25 No Call/No Show per day/per child fee will be charged. If redeeming un-used, pre-paid camp days you forfeit each available day per No Call/No Show day/per child.

## **Cancellations**

You have until 2pm on the day before your reservation to cancel without fees or forfeiting any un-used, pre-paid camp days.

## **Refund Policy**

**Full Refund:** If selected Camp session(s)/Kid's Night Out is full and no alternative can be found. Must be processed before 20 hours of reservation to avoid additional \$15 Return Processing Fee.

**Partial Refund(Camp Only): If no alternative can be found** (Example: Your child comes to camp one day and realizes it's not for him/her and you purchased a week) A pro-rated amount with a \$15 Return Processing Fee will be applied and processed.

No Refunds are given for NO CALL / NO SHOWS. <u>No Exceptions!</u>
